ARKANSAS RACES

Abortion:

Arkansas' current law that prohibits abortion except to save the life of the mother in a medical emergency.

Abortion:

Establishing a permanent funding stream to provide state-funded grants to charities that provide women with alternatives to abortion.

Education:

The Arkansas LEARNS Act Educational Freedom Accounts that lets families use public dollars to pay for an education at a private school or homeschool.

Drugs:

Legalizing recreational marijuana in Arkansas.

Tech:

Requiring major social media websites to verify all users' ages in order to protect children on their platforms.

Gambling:

Letting casinos in Arkansas conduct gambling online.

Elections:

Current ballot initiative efforts to change the Arkansas Constitution to make it easier for private individuals or entities to place measures on the ballot for a statewide vote.

Guns:

Confiscation of firearms from citizens that the government deem a danger to themselves or others, otherwise known as red flag laws.

Marriage:

The U.S. Supreme Court's 2015 Obergefell v. Hodges decision that legalized same-sex marriage.
